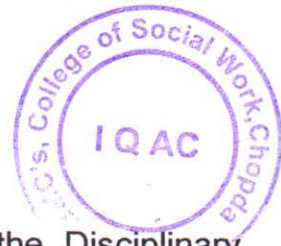


**Translation**
