
Subject No. 3 Regarding setting goals and objectives of the committee ...

VJ / NT = 11% (VJ (A) - 3%, NT (B) - 2.5%, NT (C) - 3.5% & NT (D) - 2%), SBC - 2%,
OBC - 19%.
